Tech request #1: surface pros and chargers

Tech request #2: funding for MMSt exhibition projects

Vipasha explained that certain percentages of Tech Fund budget has to go to MMSt collection/exhibition needs. This year that amount would be ~\$6000. Questions about how students would access funds. Students have to pitch project proposals with budgets and are approved by faculty. There is oversight process. The norm is that students have to pay entirely for their exhibition projects so this reduces cost barrier.

MOTION: BIRT the MISC General Council approve the Tech Fund's allocation of ~\$6000 to MMSt students' needs for collecting and exhibiting with regards to the exhibition project.
